How long we store personal data

Robert Visser Muziek will not retain your personal information longer than is strictly necessary to fulfill the purposes for which it was collected. We use the following retention periods for the following (categories of) personal data:

(Newsletter) First name, Last name, e-mail address > As long as you want to receive the newsletter > To ensure that you receive the newsletter correctly and on time > Immediately after unsubscribing data will be deleted

Sharing personal data with third parties

Robert Visser Music provides music only to third parties and only as necessary for the performance of our agreement with you or to comply with a legal obligation.

Cookies, or similar techniques, that we use

Robert Visser Muziek only uses technical and functional cookies. And analytical cookies that do not infringe on your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical operation of the website and your convenience. They ensure that the website works properly and remember, for example, your preferred settings. It also allows us to optimize our website. You can opt out of cookies by setting your internet browser to no longer store cookies. In addition, you can also delete any information previously stored in the settings of your browser.

View, modify or delete data

You have the right to access, correct or delete your personal data. In addition, you have the right to withdraw your possible consent to the processing of data or to object to the processing of your personal data by Robert Visser Muziek and you have the right to data transferability. This means that you can submit a request to us to send the personal data that we hold about you in a computer file to you or another organisation named by you. To ensure that you have requested access, we ask you to enclose a copy of your identity document with the request. In this copy, make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Burgerservicenummer (BSN) black. This to protect your privacy. We will respond as soon as possible, but within four weeks, to your request. Robert Visser Muziek would also like to point out that you have the opportunity to file a complaint with the national supervisory authority, the Personal Data Authority.
